## RULES & REGULATIONS

---

Please read all guidelines carefully before parade day.

1. Registration deadline is July 4, 2026. Completed forms must be submitted to [lori.poznansky@mhcca.ca](mailto:lori.poznansky@mhcca.ca) prior to the event.
2. All participants must be 12 years of age or under.
4. Participants must be in the marshalling area and ready to go by 9:30 a.m. The parade departs at 10:00 a.m. sharp. Latecomers may not be permitted to join.
5. Helmets are mandatory for all riders (bikes, scooters, and electric ride-ons). Helmets must be properly fitted with chin straps securely fastened.
6. Children under 10 years old must be accompanied by a parent or guardian at all times. If a child is unable to keep up, the accompanying adult must assist or guide them off the route.
7. Bikes, wagons, scooters, and electric ride-on mini cars are welcome. Large, motorized vehicles are not permitted.
8. Decorations must be securely attached and must not obstruct the rider's vision, interfere with wheels or moving parts, or pose a hazard to other participants.
9. Pets participating must be on a leash and under the handler's control at all times. Owners are responsible for their pet's behaviour and clean up.
10. Participants must stay on the designated parade route and maintain a safe distance from other participants.
11. Entries must be family-friendly and in keeping with the spirit of the fair. Nothing inflammatory, offensive, or inappropriate will be permitted.
12. No solicitation, distribution of flyers, or commercial advertising. Club or team uniforms and small banners identifying a group are permitted.
14. The parade proceeds rain or shine. In the event of severe weather, organizers will notify registered participants.
