**RULES & REGULATIONS**

**Please read all guidelines carefully before parade day.**

1. Registration deadline is July 4, 2026. Completed forms must be submitted to [summerfair@mhcca.ca](mailto:summerfair@mhcca.ca) prior to the event.
2. Submitting an application does not guarantee participation. The MHCCA reserves the right to accept or refuse any entry.
3. All participants must be in the marshalling area at the Eastern Shore District High School in Musquodoboit Harbour by 10:15 a.m. Floats larger than 35 ft must line up by 10:00 a.m. The parade departs at 11:00 a.m. sharp. Latecomers may not be permitted to join.
4. Judging will take place between 10:30-10:45 a.m. Late floats will not be eligible for judging.
5. In the case of emergency, all floats must keep to the right lane to allow emergency vehicles to pass freely through the parade route.
6. Parade is single file. Participants must stay on the designated parade route and maintain a safe distance from other entries and spectators at all times.
7. If a float entry breaks down, the entry must leave the parade immediately or as soon as is safely possible.
8. All vehicles must be legal for the road, including valid registration, safety inspection, and insurance. All drivers must be properly licensed.
9. The use of open fire, gas, or propane on any float or vehicle is not permitted. All electrical devices must meet safety standards.
7. All children participating must be supervised by a responsible adult at all times.
8. All entries must be family-friendly and in keeping with the spirit of the fair. Nothing inflammatory, offensive, or inappropriate will be permitted.
9. All entries must be clean, neat and in reasonable repair.
10. Candy, advertising, or other materials CANNOT be thrown from a float. Please have participants walk alongside your float to pass out candy and other items.
11. Animals must be on a leash or under handler control at all times. Owners are responsible for their animals' behaviour and clean-up.
12. The parade proceeds rain or shine. In the event of severe weather, organizers will notify registered participants.
